Laws

Each State and Territory has a range of anti-discrimination and human rights laws. The grounds of unlawful discrimination in all States and Territories include disability.

Unlawful discrimination is regulated in the various areas of public and private life. Each system differs in the areas regulated under the anti-discrimination law, but examples include employment, education, access to places and vehicles, the provision of goods, services and facilities, accommodation, memberships of clubs, partnerships, superannuation and insurance, and the conferral of qualifications.

Complaints about discrimination or human rights violations can be made to the State and Territory Anti-Discrimination Agencies. Each of these agencies can also provide you with information about the anti-discrimination laws operating in their State or Territory.
